### RULES & REGULATIONS

**Please sign the bottom of this document stating that you have read and understand.**

1. The Community Yard Sale takes place on Saturday, February 9, 2013, from 8:00 AM to 1:00 PM, in the Seaside Amphitheater.
2. The event will occur, rain or shine.
3. The event will work to accommodate space requests; however, makes NO GUARANTEE that space requests will be honored.
4. Table registration fee is \$150.00/table, tax included. Tables are 8ft while supplies last. There is a limit of 4 tables/vendor.
5. Payment of space is a commitment for participation. No tables will be held without advance payment.
6. Refunds will not be offered once a space is confirmed, even if we experience inclement weather on the day of the event.
7. The Community Yard Sale will provide table(s) and chair(s). The event asks that no additional tables or chairs be used.
8. All table reservations will be given a parking permit that must be displayed in your vehicle's front windshield at all times.
9. After unloading, all vehicles must be removed from Central Square by 7:45AM and moved to the county parking lot between Seaside & WaterColor or to the additional offsite parking location. No vendor parking will be allowed in other areas of Seaside.
10. No overnight parking will be permitted at Seaside. Any vehicle left overnight is subject to towing at the owner's expense.
11. Set-up begins at 5:00 AM and must be completed no later than 7:30 AM. Tables will be assigned by LAST NAME or BUSINESS NAME. Tables are located in Amphitheater. Due to space limitations, we ask that you do not move the tables from their original location.
12. All merchandise must be kept within 6ft from the back of your table(s) & 2ft from the front of your table(s). No set-up will be allowed to the sides of your table(s). Please adhere to these restrictions due to space limitations.
13. Clothing is permitted; however, we request that you use no more than two clothing racks per space reservation.
14. No concession (food/beverage) items are allowed at any point during the event. There are no exceptions.
15. Clean up is to begin promptly at 1:00 PM and must be completed by 2:00 PM.
16. Kindly pick up around your space following the completion of the event. Do not leave behind any trash or merchandise after the sale. Remaining items may be donated to Caring & Sharing of South Walton who will be on hand near completion of event.
17. The following items are not accepted at this sale: merchandise that is not authentic, replicas of original products, political or religious handouts, pornographic or nude material, and anything viewed by the Seaside Arts & Entertainment Corp. that is not deemed acceptable to a family audience.
18. Please refrain from the use of tents or umbrellas during the sale, even in the event of inclement weather.
19. Please follow all of the guidelines as listed above. If you are unable to follow these guidelines, we will ask the participant to leave and your table fees and deposit will not be refunded.
